SUBJECT: Guidance on Unique Identification Numbers for NEPA Documents

On May 1, 2024, the Council on Environmental Quality (CEQ) published a final rule updating its regulations, 40 C.F.R. Parts 1500–1508, implementing the National Environmental Policy Act (NEPA), 42 U.S.C. 4321 *et seq.* ¹ The revised CEQ regulations require agencies to provide a unique identification number (ID) for environmental assessments (EAs) and environmental impact statements (EISs) to help the public and agencies track the progress of EAs and EISs for proposed actions as they move through the NEPA process. ² Agencies must reference this unique ID in all environmental documents associated with an EIS or EA initiated after the July 1, 2024, effective date of the final rule. ³ Agencies also must reference the unique ID in any database or tracking system for such documents. ⁴

This memorandum provides a recommended approach for establishing unique IDs for these documents. Please share this memorandum with the individuals responsible for implementing NEPA and the CEQ regulations, who may wish to share it with the agency's information technology staff, as appropriate. If an agency would prefer to use an alternative approach than the approach recommended in this memorandum, CEQ requests that the agency discuss its preferred approach with CEQ in advance of implementing it.

CEQ is recommending the approach in this memorandum as an important component to enable consistent, government-wide tracking of NEPA documents. A consistent unique ID format for EAs and EISs will enable future data integration between agencies and avoid confusion that may arise from multiple different ID formats used across the Federal Government. CEQ appreciates that implementation of the unique ID approach outlined in this memorandum may require an initial investment of staff time and resources, but underscores the benefits, in the form of transparency and a uniform ID system, that will flow from implementation of this approach.

Attachment 1 to this memorandum provides step-by-step instructions on how to create a unique ID based on CEQ's recommended approach, and Attachment 2 provides a more detailed

discussion of the unique ID specifications. Agencies do not need to replace internal agency tracking numbers currently in use with numbers generated using CEQ's recommended approach, and instead should include both tracking numbers—the CEQ recommended approach that appears on environmental documents and the internal agency tracking number—in agency databases and tracking systems.

Where more than one agency participates in a single environmental review under NEPA, the agencies should use a single unique ID for that review, generated by the lead agency (or by one of the joint lead agencies, as applicable). Therefore, an agency that is serving as a cooperating agency may need to track in its internal databases a unique ID generated by a different agency. This need for interoperability underscores the need for a uniform ID format, such as the format provided in this guidance. Attachment 2 provides guidance on unique IDs for supplemental and programmatic reviews and adoptions.

In addition to this guidance, CEQ has made available on <u>NEPA.gov</u> a template spreadsheet to assist agencies with creating unique IDs. CEQ acknowledges that the recommended approach may be new to many agencies and CEQ's NEPA staff is available to assist with implementation of the new requirement to provide unique IDs. Step-by-Step Instructions for Creating a Unique ID

CEQ's recommended approach results in a unique ID that includes five segments: a four-character Process segment, a three-character Department/Agency segment, a two-character Bureau/Component segment, a three-character alphanumeric Additional Agency Organization segment, and a ten-character Timestamp segment. An example of a unique ID created using this approach is as follows:

CEQ has chosen to use an existing two-part Office of Management and Budget (OMB) numbering convention from OMB Circular A-11 for identifying the department (or agency) and bureau (or component) in the CEQ unique ID (see table in Attachment 4). Relying on this existing numbering system avoids duplication and will promote consistency across agencies. CEQ requests that agencies develop their own list of agency sub-components to identify offices within the agency or bureau that are charged with issuing EAs and EISs (e.g., program, district, division, regional, or field offices). This list should then be used to populate the Additional Agency Organization segment.

Creating a Unique ID

Step 1: Using the table below, select the appropriate four-character process ID for the **Process segment** of the unique ID. For further information on when to use the programmatic or supplemental process IDs, refer to page v of Attachment 2.

- Step 2: Using the table in Attachment 4 of this guidance, select the appropriate three-character agency code and two-character bureau code, which will serve as the **Department/Agency and Bureau/Component segments** of the unique ID, respectively.
- **Step 3**: The **Additional Agency Organization segment** of the unique ID should consist of three alphanumeric characters. Agencies may develop their own lists of agency sub-components (e.g., program, district, division, regional, or field offices) to populate the Additional Agency Organization segment. If the agency preparing the EIS or EA has not prepared such a list, use the characters 000 for this segment of the unique ID.

- **Step 4**: Create a ten-character timestamp for the **Timestamp segment** of the unique ID using the following formula in a spreadsheet program: =TEXT((NOW()-DATE(1970,1,1))*86400, "0")
- **Step 5**: Combine the five segments to form the NEPA unique ID, for example:

More detailed specifications for the recommended approach to the unique ID requirement are provided in Attachment 2.

NEPA Unique ID Specifications

I. NEPA Unique IDs and Other Data Types

To support agency implementation of the unique ID requirement, this memorandum provides a taxonomy,⁵ or classification system, that defines various terms related to NEPA processes and the relationships between those terms. The system can aid agencies in complying with the unique ID requirement and in understanding how the unique ID can fit into the broader permitting landscape. Further, this system accommodates related permitting processes that are not covered by this guidance.


This guidance provides agencies with a consistent approach that fulfills the CEQ NEPA regulations' requirement for each EIS and EA to have an associated unique ID. In order to clarify what that requirement applies to, CEQ has defined a high-level taxonomy that includes three hierarchical levels (see Figure 1) associated with agency actions. The top level—referred to as a "project" in this guidance—is the major Federal action for which the agency is preparing an EA or EIS. The second level—referred to as a "process" in this guidance—is the level of NEPA review, i.e., EA or EIS (and also could include categorical exclusions (CEs)); this is the level that requires a unique ID for EAs and EISs. The third level—referred to as a "document" in this guidance—is the particular environmental document the agency prepares as part of the EA or EIS process (e.g., notice of intent (NOI), EA, draft EIS, final EIS, record of decision (ROD), or finding of no significant impact (FONSI)) on which the agency uses the ID.

⁵ A taxonomy for the NEPA process is a classification system that defines data types and their relationships to provide a framework for how information should be structured for NEPA processes and within data systems tracking such processes.

⁶ From a data management perspective, these levels correspond to "objects," which are abstract concepts that represent real-world entities in a data system. An object has attributes or properties as well as relationships with other objects.

⁷ While the CEQ NEPA regulations do not govern other permitting processes, from a data management perspective, a project may have other processes associated with it, such as a permit or other authorization. While this guidance is focused on the NEPA review process, these data management concepts are generic, and agencies could apply the concepts in this guidance to extend the CEQ unique ID system to other environmental review or permitting processes if doing so provides value to agencies and other stakeholders.

Figure 1: This diagram shows the three related concepts in the classification system with examples from an EIS process and a generic permitting process.



There may be other concepts in a NEPA or permitting taxonomy, but this guidance addresses the project, process, and document concepts. The CEQ regulations require agencies to include a unique ID associated with a single *process* (i.e., an EA or EIS) on associated environmental documents and in any agency databases or tracking systems.

The standards described in this guidance relate to *external* IDs that are used to identify particular EA and EIS processes outside of the agencies and do not preclude agencies from using any additional internal IDs.

II. Implementation of the Unique ID Requirement

Agencies must create a unique ID for each action for which they prepare an EIS or EA, and reference this unique ID on each environmental document associated with that action (e.g., NOI, draft EIS, final EIS, ROD, EA, or FONSI).⁸ As explained in detail below and set forth in Figure 2, the recommended unique ID format has 5 segments totaling 22 characters, which together comprise the unique ID.

The lead agency should share the unique ID with cooperating and participating agencies, which should use the unique ID generated by the lead agency rather than creating their own unique ID.

Figure 2: In this table, the unique ID, EISX-005-96-63Y-1714567500, indicates that the process is an EIS (process code EISX), prepared by the Department of Agriculture Forest Service (Agency segment 005 and Bureau segment 96) in a particular Forest Service field office (Additional Agency Organization segment 63Y), and that the unique ID for the process was generated at 8:45:00am EDT on May 1, 2024 (Timestamp segment 1714567500).

Process ID

The four-digit Process segment identifies the level of NEPA review, as listed in Figure 3. The CEQ regulations only require agencies to provide unique IDs for EAs and EISs. The approach set forth in this guidance provides further clarity by providing distinct process abbreviations for programmatic and supplemental EAs and EISs. Moreover, this guidance also provides an abbreviation for CEs, if agencies choose to assign a unique ID to CE determinations.

In addition, because agencies may want to use a similar ID format for other processes besides NEPA reviews (e.g., various types of permits or authorizations), Attachment 3 includes a process ID lookup table for those permits and authorizations listed in the <u>Federal Environmental Review and Authorization Inventory</u>, which was developed to assist with the development of timetables for infrastructure projects posted to the Federal Permitting Dashboard.

Department/Agency and Bureau/Component

For both the Department/Agency and the Bureau/Component segments of the unique ID, the lead agency for the NEPA process should use the OMB codes for agency and bureau identified in Appendix C of OMB Circular A-11,¹⁰ and add leading zeros, where necessary, to ensure that the Department/Agency segment is three characters long and the Bureau/Component segment is two characters long. States or Tribes that have assumed NEPA responsibilities from a Federal agency may use the OMB codes of the agency that assigned this responsibility and may work with that agency to establish a code specific to the applicable State or Tribe in the Additional Agency Organization segment.

Appendix C of OMB Circular A-11 does not assign Bureau codes to the services within the Department of Defense (DOD) (i.e., Army, Navy, Air Force), with the exception of Army Civil Works. Accordingly, the DOD services should follow the instructions in Appendix C of OMB Circular A-11 and use the Treasury Agency Codes at the bureau level in addition to the DOD code 007 (as explained on the final page of Circular A-11, Appendix C). Organizations with their own NEPA procedures that do not have a bureau code (e.g., the Defense Logistics Agency, First Responder Network Authority) should use their parent Department/Agency code and use the additional agency organization segment below for more specificity.

Additional Agency Organization

Agencies should specify additional levels of organization within their department, agency, or component (e.g., a district or field office or sub-agency) by defining the Additional Agency Organization segment of the unique ID, which consists of three alphanumeric characters. If an agency does not have field, district, or other sub-agency offices to define with these three characters, the agency should use code 000 when the agency does not assign Additional Agency Organization codes. If an agency elects to use values other than 000 for the Additional Agency Organization segment, the agency should establish the codes centrally for the entire organization

and disseminate them to field or district offices along with this guidance. Agencies should not define this segment on an ad hoc basis and should instead establish, maintain, and update, as necessary, a list to ensure clearly defined data.

Timestamp

The Timestamp segment ensures that agencies avoid assigning duplicate ID numbers to different actions. The agency should create the timestamp by calculating the current time, at the time that it generates the unique ID, in seconds, since January 1, 1970. This timestamp formulation is known as Unix epoch time and is widely used in computer programming. Most programming languages, databases, and applications can generate this number, as can many websites. Spreadsheet formulas can also generate this number, although it is different than the typical spreadsheet date/time formula. Copying the following formula and pasting it as a "value" into a spreadsheet cell 2 will generate a timestamp:

The timestamp relates to the point in time at which the agency generates the unique ID, not to a point in time with any significance for the process itself (e.g., the NOI publication date/time). The timestamp is an arbitrary number whose sole purpose is to ensure the uniqueness of each ID and distinguish between the IDs for different actions undertaken by the same agency; therefore, it does not matter which time zone the agency uses to generate the timestamp or when the timestamp is generated. Agencies should not round the timestamp to the nearest minute because the precision of the time matters for ensuring the uniqueness of the number.

Resources for Generating Unique IDs

In addition to this attachment, CEQ is providing to agencies a spreadsheet with dropdown lookups to assemble the unique ID. For agencies that will manually generate unique IDs, CEQ encourages them to adapt and customize this Excel spreadsheet into a user-friendly internal tool.

Supplemental and Programmatic NEPA Reviews and Adoption

For an EIS or EA that an agency prepares to supplement prior analysis, the lead agency should generate a new ID if the previous "parent" process has been completed (i.e., if the EA has been published or the ROD has been issued). On the documents prepared for the supplemental EA or EIS, the agency should include both the unique ID for the original EA or EIS and this new ID. If the original NEPA process has not been completed when the supplemental process begins (i.e.,

¹² Note that the formula will generate a new timestamp every time the sheet recalculates; therefore, the timestamp would change any time the sheet is opened or recalculated. Regardless of how the agency generates the timestamp, once the agency applies it to a specific project, the agency should not change the timestamp.

the agency has not yet issued a ROD or FONSI), the agency should use the original unique ID for the supplemental documents and should not issue a new unique ID.

For programmatic NEPA reviews, agencies should use a unique ID for a programmatic document and generate a new unique ID for each tiered document prepared after the programmatic document is complete. Agencies should include both IDs on documents associated with the tiered review.

In general, if a process is linked to a previous or parent environmental review process through supplementation or tiering, agencies should include the unique ID of the previous or parent process in addition to the site-specific or tier two unique ID.

If an agency adopts another agency's EIS or EA, it should generate a new unique ID and include that ID on any environmental document related to the adoption, along with the original unique ID associated with the adopted EIS or EA.

Example of Programmatic and Tiered EISs

The following example demonstrates how an agency should generate and use unique IDs for a programmatic EIS and a site-specific EIS tiered to the programmatic EIS:

A programmatic document prepared by the Bureau of Ocean Energy Management (BOEM) for an offshore wind leasing area has the unique ID *PEIS-010-06-000-1611323100*.

A subsequent site-specific EIS prepared by BOEM for a project within the lease area has the unique ID *EISX-010-06-000-1682169322* as well as the associated programmatic document unique ID *PEIS-010-06-000-1611323100*.

Example of Supplemental EISs

The following example demonstrates how agencies should generate and use unique IDs for supplemental EISs:

An initial EIS prepared by the Bureau of Land Management (BLM) for a vegetation management project has the unique ID *EISX-010-04-000-1675088535*.

A supplemental draft EIS prepared by BLM after publication of the original draft EIS, but before publication of the final EIS, would include the same unique ID.

A supplemental EIS prepared by BLM after issuance of a ROD for the initial EIS has the unique ID *SEIS-010-04-000-1706711590* as well as the associated initial EIS unique ID *EISX-010-04-000-1675088535*.

Example of EIS Adoption

The following example demonstrates how an agency should generate and use unique IDs for an EIS that it adopts when it was not a cooperating agency, and therefore must recirculate the final EIS:

The U.S. Coast Guard (USCG) recirculates a final EIS for a Bridge Permit associated with a Federal Highway Administration (FHWA) EIS for which USCG was not a cooperating agency. The recirculated EIS would include the unique ID *EISX-024-60-000-1710340390* as well as the associated FHWA EIS unique ID *EISX-021-15-00-1702650780*.

Process IDs

The following four-digit process IDs should be used as part of the unique ID required by CEQ's NEPA regulations. The regulations only require agencies to provide unique IDs for EAs and EISs, but agencies may wish to use a similar ID format for other processes besides NEPA (e.g., permits or authorizations). Therefore, CEQ has included a list of suggested process IDs for other permits and authorizations listed in the <u>Federal Environmental Review and Authorization</u> Inventory, which was developed to assist with the development of timetables for infrastructure projects posted to the Federal Permitting Dashboard.
